Storage Conditions

Keep container tightly closed and store in a cool, dry and well-ventilated place. Protect container from physical damage. Protect from moisture. DO NOT add to warm or hot water, a violent eruption or hazardous explosive reaction can result. When making solutions or diluting, only add sodium hydroxide slowly to surface of cold water while stirring. Keep out of the reach of children. Store locked up.
