### Methods for cleaning up

Sweep up and shovel into suitable containers for disposal. Avoid dust formation. Powdered material may form explosive dust-air mixtures. Contain spillage, and then collect with non-combustible absorbent material, (e.g. sand, earth, diatomaceous earth, vermiculite) and place in container for disposal according to local / national regulations (see section 13).
